

TIOB MANAGEMENT

In accordance with Article 18(a) of the Constitution of the Institute, the management of the Institute is vested to the Governing Council whose members shall not be less than five and not more than fifteen. The Constitution further states that the Council members shall be natural persons and shall be subject to retirement after three years at the Annual General Meeting of the Institute. A retiring Council member shall be eligible for re-election.
