It provides important personal and business contacts and a rare opportunity for valuable exchange of views in both a professional and social perspective.

## The School's Objectives

- III. Making them aware of and appreciate the wider issues with which they have to deal with and equip them with the knowledge and skills appropriate to cope with their increased responsibilities.
- IV. Enhancing their industry-level awareness through participation in case studies and discussion groups, with reference to their institution's business strategy and personal journey.
- V. Helping them to meet the current challenges facing banking and financial services.
- VI. Contributing to the development of highly skilled, professional and competent bankers in the region and across the continent.



# The School's Programme Content

Based on the above Central Theme, the following sub-themes have been identified as some of the key discussion points;

## i. General Overview of ESG

ESG has become a core component of sustainable finance and risk management. Regulators, investors, and customers increasingly expect banks to integrate ESG principles into their strategies, operations, and lending practices. By featuring ESG as a subtheme, the conference addresses how the financial sector is responding to global sustainability challenges while aligning profitability with responsible banking.

- Environmental: Climate risk assessment, green financing, carbon footprint reduction, and investment in renewable energy initiatives.
- Social: Financial inclusion, equitable lending practices, community investment, employee diversity and welfare.
- Governance: Ethical decision-making, anti-corruption measures, transparency, regulatory compliance, and board accountability.

## ii. Sustainability in Business and Finance

This subtheme explores how banks and financial institutions can drive sustainable economic growth by integrating Environmental, Social, and Governance (ESG) principles. It emphasizes green finance, responsible investing, climate risk management, and the role of regulation and innovation in building a sustainable financial system.
